CONSENT ORDER ON WIFE'S MOTION TO  
DETERMINE CONFIDENTIALITY OF COURT RECORDS

**THIS CAUSE** came before the Court on Wife's Motion to Determine Confidentiality of Court Records (hereinafter referred to as "Motion to Determine Confidentiality"). The parties have reached an agreement as evidenced by their counsels' signatures attached hereto. The Court ratifies, confirms, and approves the agreement entered into by the parties. Upon reviewing the pleadings and being fully advised in the premises the Court finds as follows:

- A. On July 29, 2015, Wife filed a Notice of Request to Take Judicial Notice of the Decision in the Case of Elena Lyke in her Claim for Disability and Disability Insurance Benefits (hereinafter referred to as "Disability Decision") entered by the Honorable Judge John D. Thompson Jr., United States Administrative Judge.
- B. Wife indicates in her Motion to Determine Confidentiality that the Disability Decision contains information regarding Wife's medical condition and history.

C. Pursuant to Florida Rule of Judicial Administration

2.420(e)(3), the Court finds the following:

- a. The undersigned order is entered in a Dissolution of Marriage action;
- b. The Disability Decision is determined confidential pursuant to Florida Rule of Judicial Administration 2.420(c)(9)(A)(vi), (vii);
- c. Neither party's name is determined confidential;
- d. The court docket containing information regarding the filing of Wife's Motion to Determine Confidentiality and the filing of the undersigned order are determined not be confidential;
- e. The Disability Decision is determined confidential;
- f. Court administration and judicial officers may view the Disability Decision.

D. Pursuant to Florida Rule of Judicial Administration

2.420(e)(3)(i), (ii),

The degree, duration, and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in subdivision (c), and no less restrictive measures are available to protect the interests set forth in subdivision (c) . . . .

- E. The parties agree the Disability Decision should be designated confidential by the Court.
- F. The Court has jurisdiction over the subject matter herein and of the parties hereto.

Accordingly, it is **ORDERED**:

1. Upon consent of the parties, the Court grants Wife's Motion

to Determine Confidentiality and designates the Disability Decision confidential.

2. Pursuant to Florida Rule of Judicial Administration 2.420(e)(4), the clerk of the court is directed to publish the order as follows:


- a. Within ten (10) days following the entry of the order the clerk of court must post a copy of the order on the clerk's website and in a prominent public location in the courthouse; and
- b. The order must remain posted in both locations for no less than thirty (30) days.


